Where a HI Service Alert is present for duplicated patient records, now when patients are merged these will automatically close off where that is the **primary issue**. Where duplication and other issues are present, the Alert must be resolved separately.

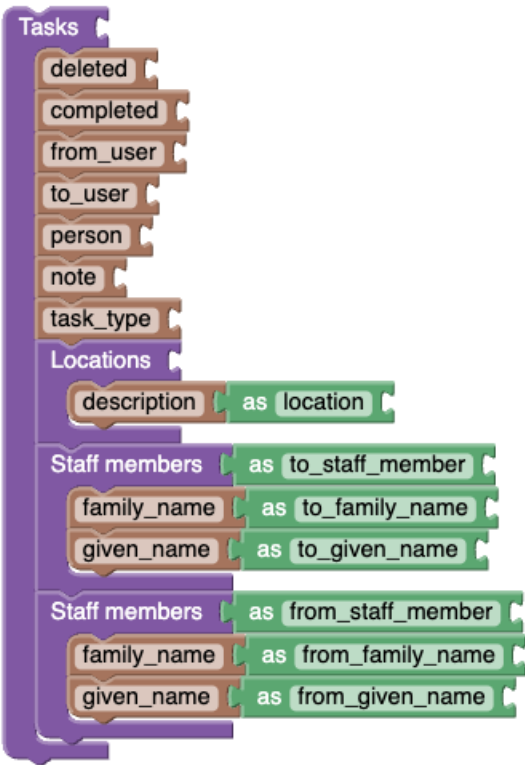
