Anti Virus on File Uploads enabled by default

Previously, this feature was optional. In order to harden the CareRight application against malicious actors; this is now a product default.



Our staff selector now takes an optional *type*, so particular groups of individuals can be shown; ie *Registered Nurse* or *System Administrators*.


