

Enhancements

Calendars > Focus on specific location

Previously, the Calendar System allowed the construction of a *Calendar View* which was a collection of providers. If you were a power user and connected to multiple locations; as well as one of those providers operating across multiple locations; it would be possible to create a calendar view that showed unnecessary information.

We have now added a Location filter, defaulting to All Locations, for this scenario.

Following written advice, WA Health has requested HMDS data to be submitted in the previous format (2015-2023).

Note: Customers will receive this change as a settings change, or in any releases equal to or higher than 6.90.2.
